3. In past the said premise was not having electric supply/ having electric supply through Consumer AC No. _____ with Meter No. _____. There are no outstanding dues in respect of the said premise. In case any outstanding dues or any vigilance claim

- or amendment claim are surfaced/ noticed later on at subsequent date and claimed by the LICENSEE, I do undertake to pay the same immediately, failing which my electric supply be liable for disconnection.
4. I will not have any objection for installing energy meter & providing electric connection to any other applicant / consumer from same service cabin where my electric meter is/ will be installed.
 5. In the event, if the landlord or lawful occupant or any statutory authority raises objection regarding authorization of said premise or evicted by due process of law, or any of the information of documents are found invalid or forged / fraudulent / or not absolutely correct and breach of any of the terms & conditions of application, my electric supply shall be liable for disconnection without any notice/ intimation to me. AND in case of change of name, I agree to maintain statuesque as prior to register the referred application.
 6. I, the applicant do hereby indemnify & keep indemnified the licence and the Undertaking and the Corporation and the person claiming through or under him or them respectively against any cost, charges. Expenses and damages, which may be incurred by the licensee in consequence of any claim or proceedings, which may be made or adopted by or on behalf any person in respect of the said premise and / or Land.
