Terms and Conditions of Contract

- i) The period of contract for Doctors appointed on contract basis will be of 11 months duration per occasion. Further renewal of contract for the same duration by giving one day's break ~~will~~ will be at the sole discretion of the General Manager and further subject to their work, conduct and attendance being found satisfactory.
- ii) They will be paid an all inclusive fixed remuneration of Rs. 35,000/- per month on pro-rata basis. They will be issued a Bus Pass for free travelling facility on the Undertaking's buses.
- iii) They will be required to devote 6 hrs and 30 mins from Monday to Friday and 4 hrs on Saturday, except Bank Holidays. Their reporting timings will be fixed by the Chief Medical Officer and they will have to attend to their duties at the Medical Centre/s of the Undertaking, which shall generally be between 10.00 hrs. to 17.00 hrs.
- iv) They will be allowed to avail Casual Leave on pro-rata basis during the contractual period of 11 months.
- v) They will be free to have their own private practice provided such practice does not interfere with their hours of work and duties as Doctor in the Undertaking.
- vi) Investigation/treatment etc. of the candidates/employees should not be carried out by them in their own private clinics and/or hospitals to which they are attached.
- vii) They will not be considered for appointment to the post of Deputy Medical Officer or any post on regular basis in the Medical Dept.
- viii) In all other respects, their services on contract basis will be governed by the terms and conditions of contract, and in case of breach of any condition of the contract, their services will be terminated at the discretion of the General Manager.
- ix) Their appointment can be terminated by either party by one calendar month's written notice or remuneration.
