



## **Mumbai – Capital of Maharashtra**



- Mumbai is the capital of Maharashtra and considered the financial capital of India
- Greater Mumbai is spread across an area of 437 sq. km. and has a population of 12.8 million (BMC's 2020 estimate)
- Greater Mumbai can be geographically divided into 3 parts: i) Mumbai city, ii) the Western Suburbs, iii) the Central Suburbs and is governed by Brihanmumbai Municipal Corporation (BMC)
- City buses services in Mumbai are provided by the Brihanmumbai Electricity Supply and Transport Undertaking (BEST) an autonomous entity under BMC
- BEST is the second major public transport operator after suburban railways in Mumbai Island City
   & Mumbai Suburban region (Mumbai Municipal Region).
- On an average, 2.9 million passengers travel daily in Mumbai through 63,700 trips in 3,800 BEST buses.
- BEST has two businesses: 1) Electricity distribution to Mumbai city, 2) City buses service to all parts of Greater Mumbai

## **BEST's Bus Depot and Bus Stations**



• BEST operates its city Bus service through 27 Bus Depots and 55 Bus Stations spread across Greater Mumbai

### • Bus Depot:

- Contains facilities for maintenance, repair, parking and fueling of buses
- Depot management oversees and controls Bus Stations mapped to it, including monitoring of fare-box collection
- Facilities for Bus drivers and conductors

#### • Bus Station:

- Serves as a terminal for Bus routes
- Basic facilities for passengers and Bus crew
- BEST aims to have a 100% electric bus fleet of 10,000 buses by 2026
- To cater to this increased parking need, BEST aims to redevelop its Bus Depots and/or Stations into state of art "Green" facilities with increased Bus parking capacity and better amenities for passenger and crew and with better gender friendly features

BEST intends to undertake phase wise redevelopment of its existing public Bus Depots and Stations into world class facilities, integrating commercial development to accommodate future demand for facilities and generate non-fare revenue to BEST to enhance its financial sustainability and make public travel more convenient


